TO: Property owners and residents of the Charter Township of Hampton:

PLEASE TAKE NOTICE that the Charter Township of Hampton Zoning Board of Appeals will conduct a public hearing on Thursday, August 22, 2024 at 6:00 p.m., in the hall or meeting room of the Hampton Township Hall, located at 801 W. Center Avenue, Essexville, Michigan 48732, to consider the request of Consumers Energy for three (3) variances on a parcel of property having parcel number 070-040-200-020-00, property description listed below, for variances from the Township Zoning Ordinance, Chapter 29, Section 29.05.B.1; 29.05.O.3.b; and 29.05.O.3.c. The property in question is zoned R-7. The first variance that the applicant is requesting is to request the reduction of the required front yard setback from 300 feet to 100 feet along the Jones Road frontage to permit the installation of solar facilities on the subject parcels. The second variance requested is to reduce the use of evergreen trees and bushes in lieu of alternative planting materials while also requesting credit for the use and conservation of existing vegetation. The third request is to eliminate the requirement for the installation of berms associated with the proposed solar facility.
